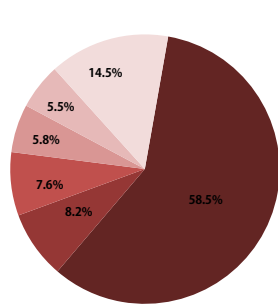

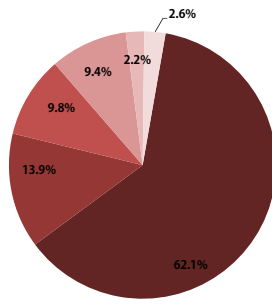
In April 2017, increment was observed for GST, Tourism Land Rent, Airport Service Charge (ASC), Remittance Tax, WHT and Land Acquisition and Conversion Fee. Thus, 26.5% increment compared to April 2016. Revenue outperformed the projection, due to the timely payments of WHT and the receipt of Acquisition payments from a newly leased island. Furthermore, ASC revenue increased to a record level due to the new Airport and Taxes Fee Act. Pursuant to the new Act, dues from previous years were to be settled and Airlines were to declare ASC timely to MIRA.

Contribution to Total Revenue



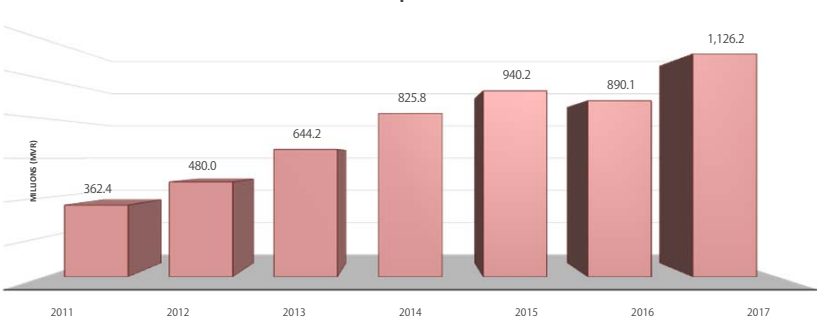
