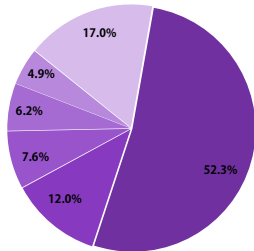

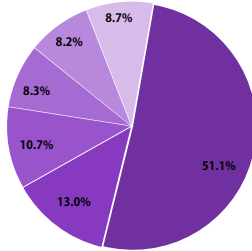
As a result of 10.1% growth in tourist arrivals compared to the corresponding period of 2017, receipt of tourism related revenues were higher-than-expected. Along with this, Lease Period Extension Fee to extend the lease period to 99 years was also received in August 2018, which collectively led to a significant increment compared to projection. However, compared to August 2017, a slight decrement was recorded since a substantial payment towards a newly leased island was received in 2017.

Contribution to Total Revenue



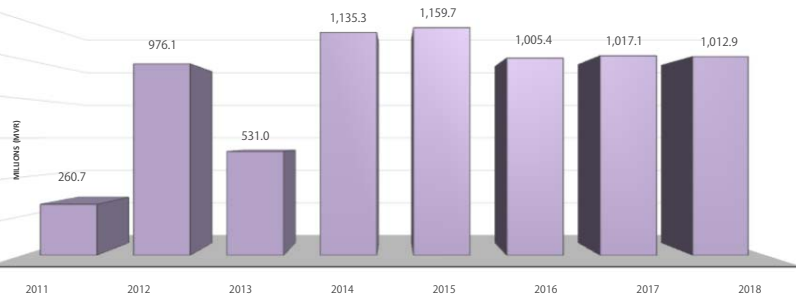
