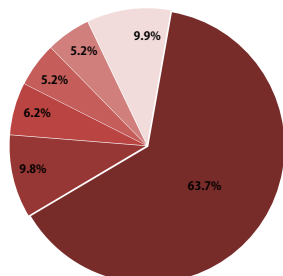

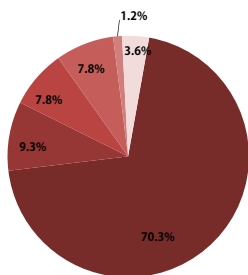
Increment in GST (TGST and GGST) and Green Tax resulted a higher collection of revenue in February 2018. Increase in TGST and Green Tax was due to the 13.6% rise in tourist arrivals when compared to January 2017. Additionally, dues recovered under MIRA's Enforcement Policy contributed to this significant increase. Furthermore, the inclusion of Airport Development Fee, which was not collected in February 2017, contributed to this increase.

Contribution to Total Revenue



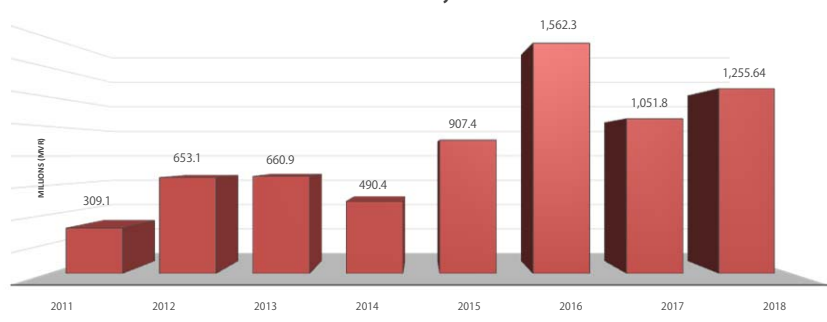
