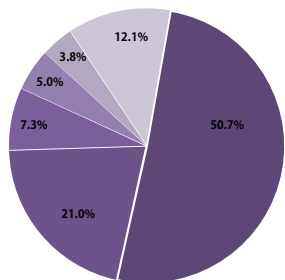

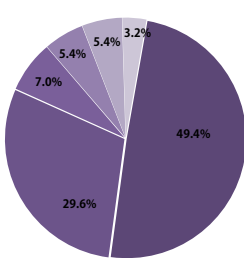
Increment in GST and BPT resulted a higher revenue in March 2018. Increase in TGST was due to the 19.2% rise in tourist arrivals compared to the corresponding period of 2017. Additionally, recovered assessed taxes of BPT and GST were higher which led to this significant increase. Furthermore, the inclusion of Airport Development Fee, which was not collected in March 2017, contributed to this increase.

Contribution to Total Revenue



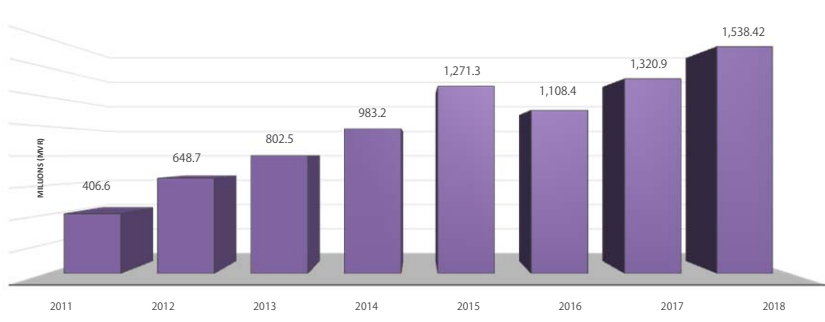
